NOW THEREFORE THE PARTIES declare their agreement as follows:

1. GENERAL PURPOSE OF THIS AGREEMENT

The parties to this Agreement have determined that it is in their respective organizations' interest to work together to create the best chance of developing and expanding academic collaboration on areas of mutual interest, and in order to reach this goal the Parties will carry out the following:

- (i) Organisation of seminars, workshops and courses of interest to both parties,

- (iv) Exchange programs for research scholars.
- (v) Other forms of cooperation as may be mutually agreed upon.
- (vi) Gender Sensitivity, Human Rights, Human Values and Environment & Sustainability
- (vii) Village Adoption, House to House Visit, Survey, Distribution of food & Clothes and other essential items during festival, Jail Visit, Orphanage Visit, Old age Home Visit and Awareness Programmes.

2. PROGRAM ELABORATION AND OTHER DIRECTIONS OF COLLABORATION

The purposes defined in Article 1 will be elaborated by special working plans, framed by the Parties. The Parties may determine other directions of collaboration, which will be formalized by signing a supplementary to the present MoU from time to time.


