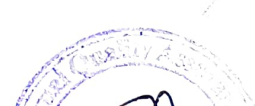


The following are the minutes of the meeting

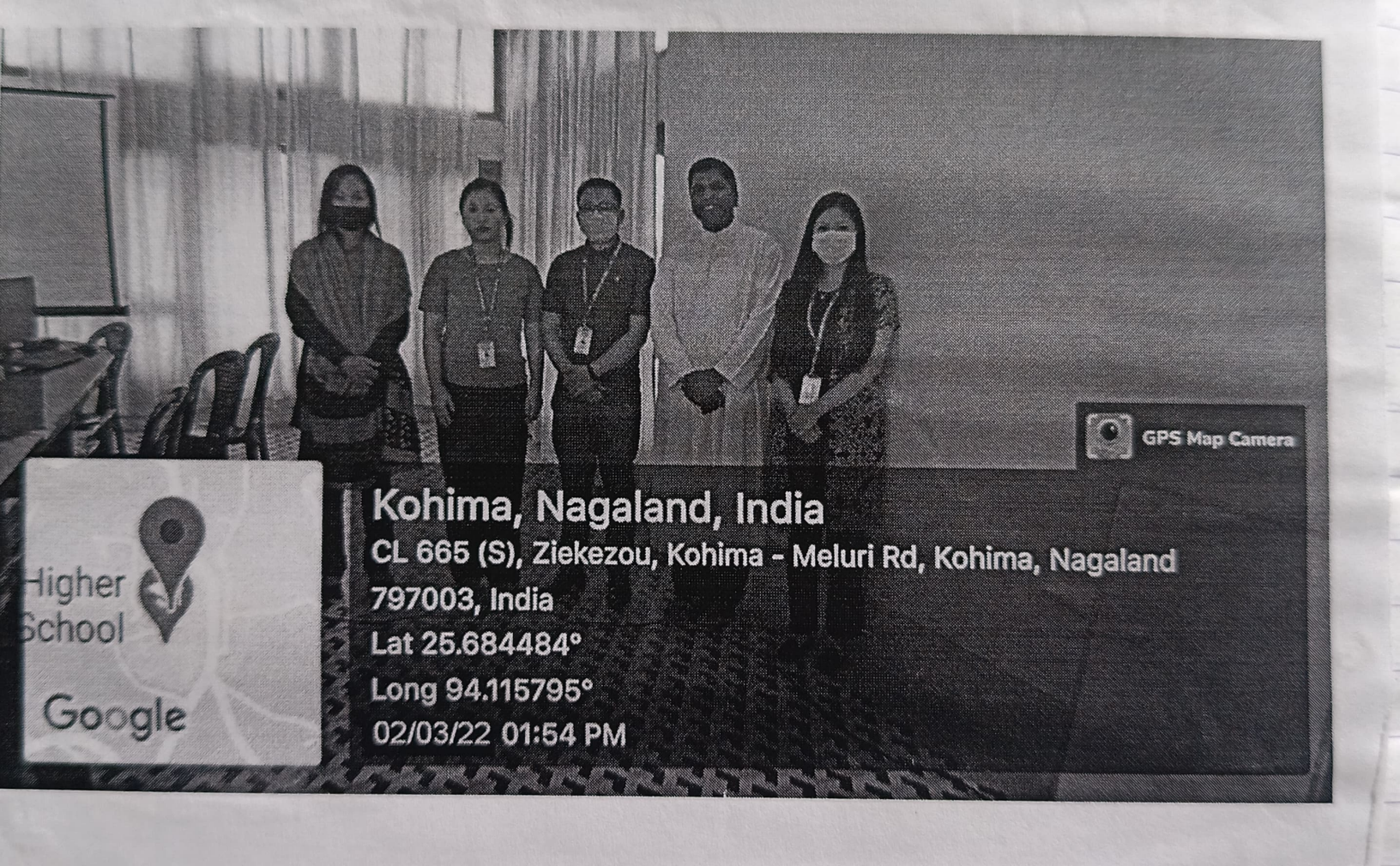
1. So far the college did not encounter nor receive any issues/complains
