installing sanitary napkin Vending machine in school premises

 Allowing Space for solar panel for powering the vending machine and saving the electricity.

Allowing clay incinerators for disposal of used sanitary napkins

- 3.1.2 FPA India, Nagaland Branch and Don Bosco College shall be part of the referral network. Set-up by FPA India where the adolescent students of Don Bosco College could have access of comprehensive SRH services including counselling, and other care and support and services offered by FPA India, Nagaland Branch
- 3.1.3 FPA India, Nagaland Branch and Don Bosco College will provide each other with technical assistance in areas where they have comparative advantages.
